Eastern Madera County Fire Safe Council — Ashley Nebeker- We got our PG&E grant to clear fuels behind Sunset off of 420. It's a smaller grant with a \$20,000 budget but we should be able to start the process of developing a shaded fuel break around there and that street is a boundary as of right now for the Mudge Ranch fire wise community, so that's good news And we are working with Sierra Nevada Conservancy to clean up an old FIRE SAFE COUNCIL fuel break off goat Mountain and that's been keeping me totally busy along with working around the ridiculous FEMA guidelines trying to get that project dialed in. The main fuel brake/roadside clearance will be a long 619 six 26,28 and 623/sky Ranch Road and pick up down Jon West, and 425B in Oakhurst.

Yosemite Sequoia RC & D – Erin Capuchino- Direct funds are approved. \$612,000 to do fuel mitigation on homes affected by storm damage. Cal fire grants should be announced soon. CERF project moving along. CERF program through the state- grant given to an organization in Fresno to do an economic development plan in a different way. Erin, Jon, and Supervisor Macauley are all on the planning committee. Writing a 20 page report on what Climate Change is doing for our county. Eastern Madera County's voice is a big deal. In-person input meetings between September and February. 26 months to complete.
