- Timely assistance to prospective communities has allowed for consistent progress in certifying new communities.
- Outreach to all Resident Leaders re: Scheduling contracted workdays, community meetings, Recertification deadline, Tool Cache reminder; continued assistance to individual communities as needed, including portal uploads for recertification efforts and new applications.
- Social Media outreach has increased the visibility in the community, leading to additional inquiries on the program.
- Review and updating maps in Arc GIS Pro allow us to quickly identify and quantify communities and surrounding forest service lands.

<u>Challenges encountered during the reporting period and possible challenges in the future (e.g., meeting</u> cancelled, unresponsive homeowner's, personnel change):

- CRCD continues to face the challenge of waiting for the in-progress communities to essentially make progress. Coarsegold RCD must wait for the committees to complete the application process in their own time.
- Lack of response for scheduling community meetings from approved Firewise<sup>®</sup> communities. Community members are not reaching out to scheduled meetings.

How challenges impact overall accomplishments and plans to remedy the situation (e.g., personnel change

required additional time to onboard for program, but they began outreaching communities this month; unexpected weather required cancelling a risk assessment, but it has been rescheduled for next month, etc):

- CRCD continued outreach to individual resident leaders through email, site visits, and community meetings has kept energy high in recertification, as well as progress on community action plans. Some communities remain silent so continued correspondence will be necessary.
- CRCD continued outreach to prospective and in-progress communities.
- We have created a new project application that can be shared with the whole community to create a list of shovel ready projects in the community.

# **Executive Director Report**

## EXECUTIVE DIRECTOR'S REPORT October 4, 2024

**CALFIRE GRANT:** We have chosen a contractor, Central Sierra Enterprises. They will provide chipping days and/or roadside fuel reduction to all Firewise communities. We need to make a budget adjustment because we spent less than expected and we want to allocate more for the trailer. We are looking to purchase the work trailer in the next month and get ready to assist communities. We are reaching out to communities to let them know we are going to be scheduling them for chipping days, unless they are opting out. We hve also visited 6 communities that needed Roadside fuel reduction and have flagged those projects. We are working on rights of entry so we can start in the coming weeks.

**MADERA FIREWISE COMMUNITIES**: Kelly has been busy helping the various new communities with their maps and initial documentation. Italian Bar, Willow Creek West, and Yosemite Forks were resubmitted with all necessary edits and we expect them to be approved in the coming weeks. Pettit has the necessary amount to start. Kelly is meeting with them this Saturday. And Woodcrest Estates/Rd 426 has the necessary 8 Participants and Risk Assessments to start the process. A meeting has been scheduled for next Thursday.

## CA FIRESAFE COUNCIL FIRE PREVENTION COODINATOR:

• Oversaw CRCD's Firewise program (3 proposed communities submitted)

- Ongoing collaboration with Jack SNA fellow (CWPP's, Social Media Posts, Be Firewise Curriculum, Firewise Newsletter). Met with NF school to plan/schedule first lesson
- Toured new fellows, Jack and Melanie around Firewise sites to get them acquainted with communities.
- Met with Greater Forestry Corps at Yosemite Adult School to discuss future workforce/ on the job training opportunities.
- Presented for Road 225 and Meadow Springs Firewise Communities
- Worked with Senior Project Student to get "Be Firewise Assessors" into Highschool program at YHS
- Attended meeting with EMCFSC and Happy Goat to discuss plan for the new CFSC State Fire Capacity grant. EMCFSC was awarded this \$100,000 grant and has CRCD listed as a partner on the grant. This grant will fund a goat grazing project around Camp Oakhurst as well as the creation of grazing protocol to assist with future projects. CRCD is written in to the grant for \$6650.00 to provide support as needed on the project, as well as help with the grazing protocol and outreach. This grant is connecting with EMCFSC's PGE grant, Americorps labor, and CRCD's Firewise funding for the Mudge Ranch community to reduce a heavily fueled area that acts as ingress and egress for the camp as well as an access point to the County's Strategic fuel break on Thornberry Ridge.
- Created and executed contract with YSRCDC for outreach, grant writing, and support services through December 31, 2024.
- Continued Work with YSRCDC on "Be Firewise" website.
- Continued Work with Yosemite Visitors Bureau on "Be Firewise" video edits.
- Attended planning meetings with Madera County, CFSC, EMCFSC, YSRCDC, and North Fork Rancheria.
- Worked with Melanie on more in depth Firewise mapping, tracking participants
- Social Media outreach on defensible space and home hardening to engage new communities.

**NACD/RCPP:** The funding for NACD 2021 TA ended on September 30. We are working on submitting a proposal for another round of funding which is due by close of business day on Monday. We will continue to share NRCS information at table events. We also have links for the programs on our web page to continue providing some outreach.

## Fork Fire Post Fire Rehab:

We are still waiting to hear back from properties on Tu Nobi and Poy Ah Now. Once outreach is complete and ROE's are signed, CRCD will move forward with additional planning.

## WCB Pollinator Block Grant: CRCD will be submitting the first report for this grant on April 20<sup>th</sup>.

We are still awaiting a decision from North Fork Rancheria regarding the "Limited Waiver of Sovereign Immunity" agreement language that I mentioned last month. We are scheduled to pick up our habitat kits October 30. If NFR has not updated the Land Owner agreement, CRCD will either sign over the kit to the tribe, and not be able to help with implementation, or will have to give the kit to one of the other planting sites.

We are preparing for our new sites this fall. Mountain oaks high school will be scheduling 2 days to help CRCD install their habitat. They will first help remove solarization plastic and help install irrigation, then they will come back out to help plant the kit. I've met with Madera RCD and Hillside Elementary again. We have limited space so we are purchasing 20 - 1 gallon native plants. North Fork School is also making pollinator habitat kits, filled with seeds they collected from the NF school habitat, to share with the participating schools. CRCD will also donate a few plugs from our xerces kits to fill in misc. areas. We will be working with the  $4^{th}$  grade class. Spring Valley Elementary will be providing us a hillside that is irrigated, but has little vegetation growing on it currently. They are going through a garden remodel, so we had to move the habitat from its original location. However, augmenting

the existing plants will be more visible for the students and help retain the hillside as well. The Thrapp Homestead will be planted around the pine trees we planted this spring at the reforestation field trip.

## RFFCP

EMCFSC has finally received the first advance funds for the RFFCP program. CRCD and EMCFSC have executed the subaward agreement. Melanie comes to us from Grizzlycorps, but is funded with this grant. She is going to use her GIS skills to help create mapping for the Regional Priority Pipeline of projects that CRCD/EMCFSC will be working to create. This also provides funds for a 6 month term for a staff member, admin time, as well as funds for trainings, supplies, and travel. (\$135,248.46). CRCD is listed as a subcontractor, so we will be invoicing EMCFSC as needed over the 23 month agreement.
